

财务管理（CGA）、会计学、财政学专业本科培养计划

Undergraduate Program for Specialty in Financial Management (CGA)、 Accounting 、Public Finance

一、培养目标

I . Educational Objectives

财务管理专业参照国际一流大学财务金融专业人才的培养模式，坚持以财务金融基础理论和应用为主的培养目标，结合国际化人才培养的需要，培养具有坚实的经济学基础和数理基础，系统掌握财务金融的基本理论知识与方法以及计算机信息技术，能从事经济金融领域的科学研究、教学、金融创新、管理等方面的工作，富有创新精神的高素质复合型人才。2001年财务管理专业是学校全英语教学的试点专业，通过实施全英语教学，使学生具有较好的英语听、说、读、写能力，具有很好的专业阅读能力。

With reference to the training program of international top universities, the Financial Management program is designed to enable students to be innovative talents with a sound grounding in economics and mathematic & physics and a thorough knowledge in financial management and information technology. Graduates will be able to do scientific research, teaching, technology development and management in the area of economy and finance. Financial Management program is the experimental unit for English teaching in our university after 2001. Graduates will have a sound grounding of English language in listening, speaking, writing and reading.

财务管理（CGA）专业培养全方位与国际接轨的一流财务管理与会计人才，系统掌握经济与财务金融学理论和方法，又有系统的会计理论知识和较强的会计实务操作能力，有较高的中英文沟通能力，具有国际视野并了解中国国情，具备在企业管理和资本市场中分析问题、解决问题的能力以及从事研究型工作的能力。

The Financial management(CGA) program aims at preparing students to be specialists with a sound grounding in the principles of economics, financial management, and system accountancy knowledge and the skills of financial management and accountancy operations, and our students can pursue a career of practical accounting and financial management in any business sector, organization and government.

会计学专业遵循“学历教育与国际（国内）注册会计师执业证书教育相结合”的培养模式，包括会计学 ACCA 方向和会计学 CPA 方向。

会计学专业（ACCA 方向）是融合现代化会计专业知识体系和职业教育内容，与国际接轨的创新型专业。采用英文原版教材全英文（双语）授课，旨在培养具有 ACCA（特许公认会计师公会）执业资格，知识面广博，专业技能精深，适应现代商务需要，能在各大型跨国公司、会计师事务所或证券金融等行业从事高级管理事务的高级会计人才。

会计学专业（CPA 方向）面向国内注册会计师职业市场，旨在培养具有 CPA（中国注册会计师）执业资格，熟练掌握现代会计管理方法和技术，通晓会计准则、财务通则，具有良好的诚信品德和职业道德素养，基础扎实、专业面宽、综合能力强的高级会计人才，成为中国注册会计师行业的优秀后备资源。

The Accounting program is designed to follow the training program of combination of academic education and the international (domestic) Certified Public Accountant certificate education, including ACCA and CPA.

The Accounting (ACCA) program is an innovative specialty achieved with international convergence, which is the integration of modern accounting knowledge system and vocational education. This program, using textbooks of English edition in English (bilingual) teaching, is designed to enable students to be professional with ACCA (the Association of Chartered Certified Accountants) qualification and to own extensive knowledge and intensive expertise. Graduates can meet modern business needs and be engaged in senior management affairs in the large multinational corporations, accounting firms or securities.

Under the Certified Public Accountant constitution, a domestic professional market, the objectives of the accounting (CPA) are:

(a) to enable our students to be professional with CPA qualification

(b) to prepare students to be specialist with a sound grounding in the modern accounting management methods and techniques, knowledge of accounting principles and financial standards

(c) to enable students, as comprehensive senior accounting personnel and CPA profession's best reserve, to be innovative talents with good moral character and integrity professional ethics, well-grounded and a breadth of professional knowledge.

财政学专业培养具备财政税收基本知识和相关理论及实践能力的专业人才。本专业要求学生了解财政学发展及中国税收制度的沿革和发展,掌握各税种的实质和内容,并将所学的理论知识灵活运用于企业税收筹划与税收征收管理,同时熟悉如社会保障等财政学领域的新兴问题。本专业培养的学生可到各类企业、跨国公司、证券机构从事税收筹划工作,也可到财政局、税务局等国家机构从事相关的税收管理工作,还可以到高等院校、科研单位从事教学和科研工作。

Public finance is to train professionals with fundamental knowledge of public finance & taxation and abilities to put related theories into practice. We require students to understand the history and development of public finance and the tax policies in China, to master the essential and contents of all kinds of taxes and smartly put them into enterprises' tax planning and tax levying & management, meanwhile to get familiar with the newly-built issues concerning public finance such as social security. Our students are expected to handle tax planning in all kinds of enterprises, cross national companies and securities, to handle tax management in public finance bureaus and revenues, also to handle teaching and researching in higher education and research institutions.

Financial Management (CGA):

The aims of the program seek to promote the following qualities:

1. Mastery of English language
2. Sound grounding and well training in economics, theory and methodology in finance;
3. Skills of qualitative and quantitative analysis in accountancy;
4. A sound knowledge of routine accountancy and relating regulations and laws;
5. A sound knowledge of international financial market and financial instruments
6. Self-learning ability and innovative thinking.

会计学专业（ACCA 方向、CPA 方向）学生主要学习会计、审计和工商管理的基础理论和基础知识，接受会计、审计方法与技能方面的基本训练，培养具有分析和解决问题的能力的基本能力。会计学专业毕业生应获得以下几方面的知识和能力：

1. 掌握管理学、经济学、会计学 and 审计学的基础理论知识；
2. 掌握会计学的定性、定量分析方法；
3. 具有较强的语言与文字表达能力、人际沟通能力、信息获取能力以及分析和解决问题的能力的基本能力；
4. 熟悉国内外会计准则、审计准则及相关的政策法规；
5. 了解本学科的理论前沿及发展动态。

As a student of this program, you will gain:

1. Knowledge of management science, economics, accountancy and auditing;
2. Skills of qualitative and quantitative analysis in accountancy;
3. The ability and confidence to use mother language, essential skills for effective communication, ability to gather information, and to identify and solve problems;
4. Understanding the accounting guideline、auditing guideline and relating regulations and laws;
5. This program highlights the ability of problem analysis and resolve.

财政学专业学生主要学习财政学、经济学和企业管理的基础理论和基本知识，受到税收征收管理及企业税收管理及技能方面的训练，具有分析和解决国家财政政策、税收政策及企业理财和税收实践方面问题的基本能力。财政学专业培养学生以下几方面的知识和能力：

1. 掌握财政学的基础理论，具备进行宏观经济管理和分析宏观经济问题的能力和素质；
2. 掌握税收理论和实践基础知识，既具备从事税收征收管理、税收政策和经济分析的能力，也具备在企业进行税收管理的素质；
3. 掌握财务管理、会计学等方面的专业知识，具备企业财务管理专业人才的基本素质；
4. 掌握现代信息技术，掌握管理信息系统的分析方法、设计方法和实现技术，并能运用于计

计算机辅助税务管理、计算机辅助财务管理的实践；

5. 掌握经济法、组织行为理论、市场营销等多方面的专业知识和技能；
6. 具有良好的人际沟通能力、英语应用能力，适应复杂工作环境的应变能力；
7. 熟悉我国财政和税收领域的有关政策和法规以及国际上的相关规定；
8. 了解本学科的理论前沿和发展动态；
9. 掌握文献检索、资料查询的基本方法，具有初步的科学研究和实际工作能力。

Public Finance:

Our students mainly focus on basic theories and knowledge of public finance, economics and enterprise management. They will get the training of taxation levying & management and the management skills of enterprises' taxation management. Then they will have the basic abilities in both analyzing and solving the public finance policies and tax policies of our country and enterprises' financing and tax practicing. Students are supposed to:

1. Master the basic theory of public finance and have the ability and power to conduct macroeconomics management and to analyze macroeconomics issues;
2. Master tax theories and tax practicing knowledge, gain the ability to handle taxation levying & management, tax policies and economics analyzing;
3. Master professional knowledge of finance management and accounting, gain the fundamental power of being a professional on finance management in an enterprise;
4. Master modern information technology and the analyzing method, designing method and realizing technology of MIS, and put them into practice for the computer aided taxation management and the computer aided finance management;
5. Master the professional knowledge and skills of economic law, and theory of organizational behavior and marketing;
6. Get the ability of good communication with others and using English as well as the ability to acclimatize themselves to the complicated working situations;
7. Understand the related policies, regulations and laws of public finance and taxation in China and the related international regulation;
8. Understand its current stage of development and the trend of related subjects; and
9. Acquire the skills to search documents and data, and abilities to do scientific research and practical job.
